Written procedure No.03, initiated on 05.05.2023

1. Description:

On 05th of May 2023 with official letter No 99-00-2-109/05.05.2023, a decision making procedure in writing for approval amendment of Eligibility of Technical Assistance Expenditures 2020-2023 of the Interreg – IPA CBC Programme between Republic of Bulgaria and Republic of North Macedonia 2014-2020, was initiated by the Managing Authority – Ministry of Regional Development and Public Works of Republic of Bulgaria.

In accordance with Articles 7 (1) and 7 (2) of the Rules of Procedure of the Monitoring Committee (MC) of the INTERREG (VI-A) IPA Bulgaria – North Macedonia Programme 2021-2027, were sent to MC members for consideration and approval amendment of Eligibility of Technical Assistance Expenditures 2020-2023 of the Interreg – IPA CBC Programme between Republic of Bulgaria and Republic of North Macedonia 2014-2020.

The proposed amendment of Eligibility of Technical Assistance (TA) Expenditures 2020-2023 concerns Budget Line 3, sub-lines "3.2. Daily allowances" and "3.3. Accommodation costs". The expenditures in both sub-lines for Bulgarian participants are updated in compliance with the amendment in the Bulgarian Decree for Mission in the Country and to the Bulgarian Decree for Mission Abroad (published in Official Gazette, no. 27 of 24.03.2023).

In accordance with Article 7 (4) of the Rules of procedure of the Monitoring Committee, the MC members had been given 3 (three) working days from dispatch of the documents to respond in writing. The deadline for comments/approval was 11th of May 2023.

No written objections, additional proposals or comments have been received within the given deadline, and it can be concluded that the MC approves the proposed measures.

2. Decisions: **The Monitoring Committee approves amendment of Eligibility of Technical Assistance Expenditures 2020-2023 of the Interreg – IPA CBC Programme between Republic of Bulgaria and Republic of North Macedonia 2014-2020**
