1. Description:

On 8th of April 2024 with official letter No 99-00-2-75/08.04.2024, a decision making procedure in writing for approval of the Guide for identified applicants to develop and submit full project proposals (Contracting Guide) under Priority 3 "Integrated development of Cross-border Region" of INTERREG VI-A IPA Bulgaria – North Macedonia Programme with accompanying annexes and attachments, was initiated by the Managing Authority – Ministry of Regional Development and Public Works of Republic of Bulgaria.

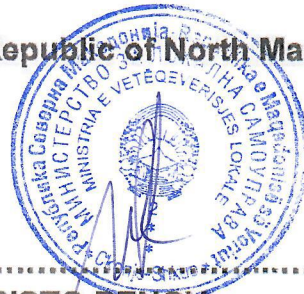
